

**The City of Kurten  
City Council Meeting Minutes  
September 24, 2013**

**Regular City Council Meeting**

1. Mayor Vitulli called the meeting to order at 7:05 p.m. Aldermen Hodge, Lindahl, Estes, and Adams were present.
2. Citizen's Comments:
